It was moved by Regent Johnson and seconded by Regent Devos that the following statement of policy concerning inter-racial social relations in connection with Women's Dormitory occupancy be approved:

"On inter-racial social relations there are observable at least three points of view: a moderate point of view somewhere between what seem to be two opposite extremes. In an endeavor to have a policy in regard to the housing of women students that may meet with the approval of a majority of the citizens of the State, The Board of Regents believes that:

"(1) The University should provide and operate an international house open to women students of any race or color whenever there may be as many applicants (sixteen) for residence in such a house as are necessary for it to be operated without financial loss either on the cooperative basis or as a dormitory furnishing both room and board without service obligations on the part of the resident as may be determined by the office of the Dean of Women (in the light of the desires of applicants) with approval of The Board of Regents.

"(2) The University should provide and operate dormitory facilities for the exclusive use of any group of women of the same race whenever there may be as many applicants (sixteen) for residence in such a dormitory as are necessary for it to be operated without financial loss either on the cooperative basis or as a dormitory furnishing both room and board without service obligations on the part of the resident as may be determined by the office of the Dean of Women (in the light of the desires of the applicants) with approval of The Board of Regents.

Supplementary Memorandum of Understanding

"(1) The University should operate Carrie Belle Raymond Hall, Julia L. Love Hall, and Northeast Hall as residences for women students of the white race.

"(2) The University should operate Love Memorial Co-operative Residence on the campus of the College of Agriculture either as a residence for white women students or as an international residence open to women students of any race or color, as may be determined from year to year by the committee responsible for selecting residents of this dormitory.

"(3) Since it is advisable to avoid agitation of inter-racial questions whenever possible, it would seem to be inadvisable to set forth this statement of policy in print, but the administrative officers of the University are to be guided by it and may appropriately quote it orally or in correspondence." Motion put to vote and carried.
